The mission of Utah Humanities(UH) revolves around offering first-hand, engaging humanities experiences. Our events are direct, personal opportunities to identify with literature, to understand local and national heritage, and to share viewpoints in civil conversations...all of which serve to strengthen the fabric of our personal and community relationships. We offer connection, context, and courage. We work with partners to extend our reach and deepen our work. In fact, everything we do at Utah Humanities is in collaboration with other organizations. Aligning with cultural, educational, professional, and service organizations is essential to fulfilling our mission, and partnering with us can result in measurable community improvement. Our statewide work at UH is divided into Centers, each of which has a specific humanities focus and associated programs. It is through our Centers that we partner with Utah organizations to improve communities through the humanities. The Centers are the Center for the Book, the Center for Community Heritage, the Center for Educational Access, and the Center for Local Initiatives.

4b (Code:) (Expenses \$ 451,367 including grants of \$ 449,554) (Revenue \$ 0)

In 2020, UH was honored to provide rapid-response emergency relief funding from the National Endowment for the Humanities (NEH) to redistribute to Utah nonprofits with humanities programs as part of the Federal Coronavirus Aid, Relief, and Economic Security Act (CARES) legislation. 35 Organizations across the state benefited from this program. All CARES funds were re-granted to Utah cultural nonprofit organizations with the exception of \$1,813, which was used for expenses directly related to the administration of the CARES grants.

Utah Humanities awards modest grants to nonprofit organizations for public humanities programs. Grants are designed to support projects that directly involve the humanities in engaging a community for the purpose of improving it. We are a proud supporter of local communities, grassroots activities, tradition, and innovation. Our grants provide invaluable financial support to help bring educational programs, interpretive exhibits and activities, local history projects, oral history projects, media projects, and more around the state of Utah.

In doing so, the Chair shall serve as a neutral and confidential conduit for the distribution, receipt, compilation and summary of the evaluation results. 2. The Board seeks evaluations and comments about the Executive Director from board and staff members in September and October each year. 3. The Chair compiles the results and associated comments from the completed evaluation forms and anonymize summaries from the staff for presentation to the Executive Director and the Executive Committee. 4. The Executive Committee reviews the results Executive Session in October. In addition, the Executive Committee reviews the evaluation tool, and if necessary, edits for the following year and recommends the ED salary for the upcoming fiscal year. 5. The Chair meets with the Executive Director to develop goals for the coming year. Goals, compensation, and any action recommendations will be shared with the full board at the fall meeting for approval. 6. At the conclusion of each year's evaluation, the Chair shall destroy all received staff evaluation forms, retaining only the prepared summaries. The Executive Director recommends staff compensation amounts to the Executive Committee annually, as part of the proposed budget presentation, and provides comparability data annually from their national membership association and the Utah Nonprofits Association. The Executive Committee's decisions are summarized in meeting minutes.
